Please note that by engaging in our services you agree to the following terms and conditions.

Health and Safety

- Our sessions are suitable for 6 months (sitting unaided) 4 years of age.
- Parents or carer's MUST accept FULL RESPONSIBILITY for their child/children who must be supervised at all times (If
 you are a parent of 2 playing children, please be sure to have a 2nd adult join the second paid child.) Please be sure not to
 LEAVE your child unattended at any given time over the session.
- Should you be required to leave messy play area for any reason please take your child/children with you and ensure they remain in your care.
- All materials are made with the knowledge they will be played with under constant supervision of a parent or carer.
- All our messy products are non-toxic and taste safe however products provided are NOT intended to be eaten.
- We do not use eggs, dairy, soy or nuts in any of our sessions. However, some products have allergy warning labels that state "may contain traces of" in these products.

- Some play stations may contain "wet" materials which could cause the floor to become slippery. Please take caution and WALK slowly around the stations to minimise the risk of slips, trips or falls.

- · Please refrain from attending sessions if you or your child have been unwell within 48hrs of the session date.
- We ask that you please refrain from attending your event should your child or yourself have a contagious illness. We reserve the right to ask you to leave a session should you display symptoms that may be contagious to others.
